

### Accomplishments





## Supporting Faculty Hires

#### Support for New Faculty Hiring

- New Faculty lines have not been concentrated in one or two departments; rather, they are spread throughout the University
- In 2018, we hired less than 10 new Faculty in any given department
- New technologies and efficiencies will hopefully streamline workloads

### FLSA

#### How We Are Preparing

- January 2019 Department of Labor plans to issue New Notice of Proposed Rulemaking (NPRM) expected which will set salary level for exemption
  - 60 days comment period to follow
  - Anticipate effective date within calendar year 2019
- Partnered with Sibson Consulting last year to analyze potential impact to employees
  - Analyzed several salary thresholds between \$30,000 to \$39,000 to determine impact to the University
  - Completed market pricing on jobs to pin point appropriate threshold for University
- Identifying how compliance with new regulations may impact exemption status again at FSU
- Continuing to stay informed
